Italian Politics

This wide-ranging book seeks to unravel the complexities of post-1992 Italian democracy. It takes as its point of departure the dramatic political tensions of the early 1990s and evaluates these against the background of an analysis of the 'First Republic' that predates these changes. Martin Bull and James Newell, renowned scholars of Italian Politics, argue that the early 1990s revolution in Italian party politics should be seen both as a major cause of subsequent changes in the political system and as a consequence of longer-term, still on-going changes in the Italian polity. The book explains how we can understand in this light the mixed success of the parties in attempting to act as autonomous vehicles of reform – and therefore why, if we are witnessing a transformation to a 'Second Republic', many of its key features still remain to be shaped. Each of the thematic chapters clearly juxtaposes Italy as it was before the 1990s with Italy today, thereby evaluating the degree to which the early 1990s can be seen as a watershed. In this way the book offers a novel account of both contemporary political developments and their historical significance in the context of the 'Italian political model' that took shape in the period after 1945. This will be essential reading for all students of Italian and Comparative Politics, who will find the clarity and breadth of the book invaluable. Equally, scholars will be fascinated by this new and compelling argument.

Politics of Segmentation

When political parties make policy decisions they are influenced by the competition they face from other parties. This book examines how party competition and party systems affect reforms of social protection. Featuring a historical comparison of Italy and Germany post-1945, the book shows how a high number of parties and ideological polarisation lead to fragmented and unequal social benefits. Utilising a comparative approach, the author brings together two important issues in welfare state research that have been insufficiently investigated. Firstly, the complex influence of party competition on social policy-making, and second, how some social groups enjoy better social protection than others. Moving beyond the two countries of the case study, the book proposes an innovative framework for studying segmentation of social protection

and applies this framework to a wider set of 15 advanced welfare states. Overall, this book draws together different strands of research on political parties and on welfare states, and introduces a new argument on how party politics shapes social policy. An invaluable text on the political economy of the welfare state, *Politics of Segmentation* will be of interest to scholars of political economy, social policy and comparative politics.

Political Data Handbook

This fully revised and updated edition of an established reference book, provides in one volume the most comprehensive and detailed statistical guide available to the government and politics of the twenty-four countries in the OECD. There is no lack of statistical data about the OECD countries (the nineteen countries of Western Europe together with Canada, the United States, Japan, Australia, and New Zealand); but much of the material is hard to track down and little is available in comparative form. The editors of the present volume have sifted through many hundreds of sources to select the essential facts and figures on population, social structure, employment, the economy, public finance, government structures, and political parties from 1950 to the present day. In addition they provide social and economic background for each of the countries covered to enable the data to be put in context. A short final section lists sources of further information. The resulting combination is both invaluable and fascinating, whether it is used casually to check up a fact or two, or systematically to make detailed comparisons between the most advanced political systems of the Western world.

Confessions of an Interest Group

Following World War II, the Catholic Church in Europe faced the challenge of establishing political influence with newly emerging democratic governments. The Church became, as Carolyn Warner pointedly argues, an interest group like any other, seeking to attain and solidify its influence by forming alliances with political parties. The author analyzes the Church's differing strategies in Italy, France, and Germany using microeconomic theories of the firm and historical institutionalism. She demonstrates how only a strategic perspective can explain the choice and longevity of the alliances in each case. In so doing, the author challenges earlier work that ignores the costs to interest groups and parties of sustaining or breaking their reciprocal links. *Confessions of an Interest Group* challenges the view of the Catholic Church as solely a moral force whose interests are seamlessly represented by the Christian Democratic parties. Blending theory, cultural narrative, and archival research, Warner demonstrates that the French Church's superficial and brief connection with a political party was directly related to its loss of political influence during the War. The Italian Church's power, on the other hand, remained stable through the War, so the Church and the Christian Democrats more easily found multiple grounds for long-term cooperation. The German Church chose yet another path, reluctantly aligning itself with a new Catholic-Protestant party. This book is an important work that expands the growing literature on the economics of religion, interest group behavior, and the politics of the Catholic Church.

Political Parties and Democracy

Final chapters complete the picture of the state of Italian society in a year characterized by a fragile government facing a number challenging issues subject to veto: the liberalization program and the uncompleted introduction of fiscal federalism, the ever-challenging management of the national health system, the role of the Bank of Italy, the relationship with the Catholic Church and the legislation on de facto couples, crime and security.

Rules, Choice and Strategy

Mixed-member electoral systems may well be the electoral reform of the 21st century, much as proportional representation (PR) was in the 20th century. In the view of many electoral reformers, mixed-member systems offer the best of both the traditional British single-seat district system and PR systems. This book seeks to evaluate: why mixed-member systems have recently appealed to many countries with diverse electoral histories; and how well expectations for these systems have been met. Each major country, which has adopted a mixed system thus, has two chapters in this book, one on origins and one on consequences. In addition, they are more likely than any other class of electoral system to simultaneously generate local accountability as well as a nationally-oriented party system. Mixed-member electoral systems have now joined majoritarian and proportional systems as basic options which must be considered whenever electoral systems are designed or redesigned. Such a development represents a fundamental change in thinking about electoral systems around

the world.

This book addresses the process of decentralization in Italy, examined from the perspective of political parties. In particular, it assesses whether and to what extent the dynamics of party competition are likely to shape policy agenda and affect policy change. The author starts by providing a thorough account of the process and history of Italian decentralization and the policy outcomes achieved over time, before discussing how party attention to an issue triggers related policy changes (manipulation of salience). Next, the focus shifts to the concrete positions adopted by parties on decentralization to assess whether the pattern of party competition has been consensual or adversarial, and how this pattern influenced the process of reform (manipulation of position). Finally, the author examines the role of frames in party competition. This volume offers essential research that will prove useful to a variety of audiences, ranging from scholars of territorial and Italian politics to those interested in agenda-setting, policy change, and party politics.

Mixed-Member Electoral Systems

Electoral systems matter. They are a crucial link in the chain connecting the preferences of citizens to the policy choices made by governments. They are chosen by political actors and, once in existence, have political consequences for those actors. They are an important object of study for anyone interested in the political process, and in this book we subject them to systematic analysis. In addition to some comparative chapters, the book contains full accounts of the operation of electoral systems in 22 countries: France, the UK, Germany, Italy, Israel, Spain, Austria, Belgium, Denmark, Finland, The Netherlands, Ireland, Hungary, Russia, Australia, Canada, India, the USA, Japan, New Zealand, Chile, and South Africa. The book provides detailed analyses of the operation of a diverse set of electoral systems in their national context. Each chapter explains how the electoral system really works in the given country, examining the strategic incentives the system provides to voters, candidates, and parties. All country chapters have a common format and structure. Successive sections analyse: the institutional context; how each electoral system was chosen historically; how the current electoral system operates (the rules, mechanics, and ballot structure); and the political consequences of the current system (the impact on the party system, the internal life of parties, and the impact on parliament and government formation). Each country chapter then contains a final section which focuses on the politicization of electoral institutions. In recent years many countries have changed their electoral systems, either entirely or in part so there is a strong focus on the processes of electoral reform, both

historically and prospectively. The book concentrates on the real world 'politics', as well as the 'political science' of electoral systems. The book will be of interest to those concerned with the practical political business of electoral reform. The book contains a wealth of evidence about the performance of various kinds of proportional representation and of non-PR systems. This will be invaluable for anyone interested in the question: 'What would be the best electoral system for my country?'

Routledge Handbook of European Elections

The question of whether Western party systems were becoming more unstable and electorates more volatile had already become central to the study of modern Europe by the end of the 1970s. Much of the literature at the time stressed how Western Europe was experiencing a phase of party breakdown, dealignment and decay, and how traditional mass politics was in the process of transformation. In this first book-length analysis of the subject, Stefano Bartolini and Peter Mair convincingly demonstrated how this emphasis on change had been largely misconceived and misplaced. This was the first systematic and conceptually sophisticated work to bring together the study of electoral change and cleavage persistence, and has since become one of the landmark volumes in the study of electoral politics in Europe. The authors examine patterns of electoral persistence and change in Western Europe between 1885 and 1985. They assess both what these patterns indicate with regard to the persistence of traditional cleavages, particularly the class cleavage, and how these patterns vary according to political, institutional and social factors. They analyse the various patterns of competition which have characterised elections across the different European countries and in different historical periods, and how cleavages can persist and re-emerge even in the face of widespread social change. They develop a sophisticated model of aggregate electoral change, in which national electorates are conceived as being torn between the stability brought about by cultural identities and organisational structures and the stimuli for change that are provoked by party competition and institutional change. *Identity, Competition and Electoral Availability* was awarded the Stein Rokkan Prize for Comparative Social Science Research and is now reprinted for the first time in paperback.

The Party Politics of Decentralization

The Italian Fascist Party in Power was first published in 1959. Minnesota Archive Editions uses digital technology to make long-unavailable books once again accessible, and are published unaltered from the original University of Minnesota Press editions. Although much significant material on the Italian Fascist party became available when the regime collapsed, scholars have not made extensive use of it until now. In this study, which is based on all the available sources, Professor Germino describes the functions of the party, explains how it was organized to perform tasks, and discusses conflicts between the party and other power elements in the dictatorship. He reaches a conclusion contrary to that of most other scholars -- that Fascist Italy was a full-fledged totalitarian state resembling Nazi Germany and Soviet Russia in political structure and ideological content. Professor Carl J. Riedrich of Harvard University writes: "I consider this a major contribution to our knowledge of totalitarian dictatorship. There is nothing in the existing literature that can be compared to it either in terms of depth or analysis, range of documentation or breadth of treatment." Professor Taylor Cole of Duke University comments: "Professor Germino has presented an excellent case study of the Italian Fascist Party. He has made use of more materials on the Party than any previous writer in English, and has marshalled them effectively to support his contention that the Fascist Party did not differ 'in kind' from [the Nazi and Soviet Communist parties] on the eve of World War II. His conclusion that on most (though not all) basic counts the Italian Fascist system was to be classified as 'totalitarian' is controversial, but it merits the careful attention of all students who are interested in the Italian Fascist period and in totalitarianism."

The Politics of Electoral Systems

What has broken apart in Italy is not just its once-mighty Left but the very bases of social solidarity. The parties of the 1990s and 2000s directly express the social demolition wrought by neoliberalism, as isolated and endangered individuals face the consequences of the crisis alone. Not this or that political party, but public life itself, is in full-scale collapse
